USE RATES

Use SUNDANCE II at 1.5-2.0 pints/acre with postemergence pesticides that suggest or require the use of COC/MSO. Some labels may suggest using SUNDANCE II at 1-1.5% v/v. Use higher rates if weed populations are dense or are stressed. Always follow the label of the specific pesticide for detailed adjuvant use directions.

MIXING INSTRUCTIONS

Always add SUNDANCE II last to the spray mix and continue agitation, unless directed otherwise by the specific pesticide label. Always follow the label of the specific pesticide for detailed adjuvant use directions.

STORAGE & DISPOSAL
